LESSON 12

Identifying Connections

Vocabulary landfills

When you read, do you know whether you are reading a factual account or someone's opinion? When you read, you need to understand the difference. A **fact** is a something that you can *prove*. An **opinion** tells you how someone *feels*. Look for words like *best* or *worst*. These words can mean the author is giving an opinion. Words like *always* and *never* often show opinions, too.

In some texts, you know the author is giving his opinion. Examples of these texts are book reviews and editorials. Sometimes, however, writers want you to agree with their position. They write to persuade you of a particular opinion. However, they should support their position or opinion with facts.

As you read, pay attention to what the author says. Does she write information that you can prove? Does it sound like the author knows what she is talking about? Is the author leaving out facts that don't support her opinions? Is the information current? Does the author present both sides of her story?

Ask yourself questions like these as you read. They will help you separate fact from opinion.

There are so many good things about recycling. Many people only think about the benefits to the environment, but the benefits don't stop there. Recycling can save money. Recycling items is less expensive than throwing them away. There is a cost to having landfills and picking up trash. When more people recycle, the cheaper it is to recycle. Recycling creates jobs. In fact, recycling has created more than a million of them!

Recycling is good for the earth, too. Every ton of paper that is recycled saves 17 trees! The more we recycle, the less pollution Earth will have.

We could do a lot better with our recycling. There are easy ways to do this. There is more to recycling than just putting cans in a recycling bin! When you go to the store, do you use paper bags? Do you use plastic bags? The best bags to use when you shop are cloth bags. These bags can be used over and over.

Other items also can be reused! Bottles and plastics can be recycled in bins to be used again, of course. You can give old clothes to charity, and you can buy used items instead of new ones. That way, items are getting another life instead of being sent to a landfill.

There are too many good things about recycling for anyone not to do it. Recycling saves energy. It saves natural resources. If we recycle more, we will need less land for landfills.

Some progress has been made. Since 1977, 2-liter soda bottles have gotten lighter, so less plastic is being used to make them. Because of that, we have saved 250 million pounds of plastic! Isn't that amazing?

Many people say that it is too hard to recycle. They do not think it is convenient. I think the facts speak for themselves. Everyone should recycle as much as possible. It makes too much sense not to.


Who decides how many things are "too many"? The other choices can be proven. However, you cannot prove how many things are "too many." This is the author's opinion. Many times you can spot an opinion by a writer's use of words. If there are words such as *best*, *worst*, *most*, *everyone*, and *nobody*, chances are there is an opinion given. Choice A is the right answer.

List two facts that Susan uses to support her main argument.



Often, facts will include numbers and dates that could be proven. This is called data, or research. Susan gives two data facts. Here is a sample answer:

- 1—Since 1977, 2-liter soda bottles have gotten lighter, so less plastic is being used.
- 2—We have saved 250 million pounds of plastic—and—every ton of paper that is recycled saves 17 trees!



Does Susan present both sides of the argument? Explain why, or why not.
Analyze Susan's argument. Does she present only her opinion? Here is a sample answer:
Susan mainly presents her side. She does bring up opposing views. She explains that some people think it is not convenient to recycle. However, she mainly supports her argument that people
should recycle.
Do you think Susan's closing paragraph helps convince the reader? Explain why, or why not.
Susan has given some good reasons to recycle in her argument. Does she continue to do this in the last paragraph? Here is a sample answer:
Susan's last paragraph does convince the reader. She presents the other side of the argument. But then she mentions facts to
support her side. The facts stand out. And she uses them well to help support her view.
